<u>Transitional Period approved: December 2020</u>

2 years → new CAP will come into force in 2023

Farm to Fork Strategy: EDA's selected actions as TEC priorities

- Action 2 (DG AGRI): at the end of 2021
- Action 11 (DG AGRI): in 2021-2022, not accurate yet
- Action 18 (DG AGRI): in 2021-2022, not accurate yet
- Action 24 (DG HEALTH): at the end of 2020
- Action 25 (DG HEALTH): in 2023, not accurate

<u>Draft Report on the F2F by European Parliament</u>

• The phrase: "We cannot seriously discuss the feasibility of these targets without any consideration for their impact on output or production costs"

COMAGRI+COMENVI joint meetings

- Encouraged the Commission in translating the Strategy into concrete legislative and non-legislative action as soon as possible
- Welcomed the reduction targets for pesticides, fertilisers, and antibiotics, emphasises the importance of pursuing these targets through holistic and circular approaches
- Consumers have a role to play

Carbon Border Adjustment Mechanism

- The European Green Deal stablishes measures which aim to slash the greenhouse gas emissions of countries in the European Union (EU) by 50% over the next decade—compared with the current target of 40%—and make Europe the world's first climate-neutral continent
- Scheduled for June 2021

• Thursday 4 February: European Parliament ENVI Committee adopted its resolution on a WTO-compatible EU CBAM

Unfair Trading Practices (UTP) Directive 2019/633
